Venue rules

- No dogs are allowed, except for assistance dogs.
- Bags larger than A4 size are not permitted inside. Please leave larger bags at home or in your vehicle if appropriate.
- Plastic bags will be provided for shopping at the event.

- All under 14s must be accompanied by an adult. I, and any minors under my supervision, will comply with all instructions given by the event organisers, employees and volunteers.

Parking

- Free parking is available in designated bays only.
- Do not park in bays marked for patients or visitors.
- Parking is only for the duration of your booked time slot.

Fitting rooms

- A limited number of designated fitting rooms will be available on-site.

Purchasing items

- All items must be weighed by a member of the St Richard's Hospice team.
- Pricing is determined based on weight and is non-negotiable.
- Payments accepted: cash or credit card (American Express not accepted).

Time slot and departure

- Please adhere strictly to your allocated time slot, and do not arrive early. Your time slot lasts one hour, starting from the time stated on your ticket. This includes time to browse the sale, weigh and pay for your items, and buy and consume any refreshments.
- Please ensure you leave promptly when your time ends to help us manage the flow of customers to this event.

Conduct and respect

- The event is held in a hospice. We ask you to be considerate while in the building, as families and friends of patients will be visiting them on our In-patient Unit. Please be respectful of the premises, staff, volunteers and visitors at all times.

Café usage

- A café will be open offering hot and cold drinks and cakes.

- No personal food or drink may be consumed on the premises.
